Eligibility

To be eligible for the HCS program, an individual must:

1. Have a Determination of Mental Retardation in accordance with State Law.
2. Be eligible for Supplemental Security Incomes (SSI) and Medicaid
3. Be eligible for an ICF/MR I, V, VI level of Care.
4. Have individual Plan of Care (IPC) for Waiver program and have made a choice for HCS over ICF/MR.

HCS OVERVIEW

Home and Community Based Service (HCS) is a program designed to assist individuals with mental retardation who meet the eligibility criteria for Medicaid and/or Supplemental Security Income (SSI) to live in the community of their choice as an alternative to institutional placement. The program enables an individual to live in his or her own home, family home, a foster care home or a residence owned/or rented by Divinity Care Center.

A periodical evaluation and recommendation, which involves a written assessment and report, indicating the individual's needs, interests, dislikes and preferences, as well as training and recreational activities are done.

This information is presented to the individuals HCS service team. The Day Habilitation program provides a wide choice of activities and training, including personal, social, adjustment training, physical fitness, manipulative arts, and community-wide integration of activities.

We work with family members to determine the plan of care. Provide transportation to and from activities of the day habilitation.
